NATURAMA is a specially developed and fully tested sustainable Hospital grade broad-spectrum cleaning agent and sanitiser that has undergone extensive laboratory testing to ensure it meets hospital grade hygiene standards.



Naturama Biocide has successfully passed **BS EN 14476**, **BS EN 1276** and **BS EN 13697**, the main British Standard laboratory tests governing disinfectants and cleaning agents.

These tests are specific to an exceptionally wide range of bacteria and viruses in tightly controlled laboratory conditions, set out in published British and European Standards.

Each threat is cultured then dosed with various dilutions of Naturama as well as a control substance.

The number of bacteria or viruses are counted and a logarithmic result is calculated called the **LOG Factor**, where Log 4 at 99.99% is the minimum kill or neutralisation level for a successful BS EN test.

There are two types of BS EN test; one is 'Clean' testing involving just the threat bacteria or virus, or a 'Dirty' test which has the Petri dish dosed with a specific contamination called an interfering substance. This is designed to replicate real life disinfection where blood, blood products and proteins exist alongside the threats.

A true 'Dirty' test is the ultimate challenge to any disinfectant and it is important to check your disinfectant has a 'Dirty' pass on the BS EN Standard to LOG 4.

Manufacturers should clearly state their test results and certifications as there are two types of disinfectants and cleaning agents on the market.

Log 4 Explained

LOG 4 is the laboratory BS EN 'pass' rate as an effective disinfectant. LOG 4 is a 99.99% kill rate where 1 million are reduced to 100.

Naturama has achieved Log 4 on a 'Dirty' test which means it was ultimately challenged in real life conditions.

Using a product that claims Log 4 'clean' test means that in a truly dirty situation it will fail LOG 4 and maybe not kill everything it claims, giving the user a false sense of security and placing both staff and public at serious risk.


